EXECUTIVE SESSION

PUBLIC HEARING ON THE 2020-2021 BUDGET

Mr. Venanzi gave a presentation on the 2020-2021 budget.

SUPERINTENDENT'S REPORT/PRESENTATIONS

Ms. McLoughlin gave a presentation on the QSAC Final Audit Results. There weren't any comments or questions from the board.

Mr. Damian Pappa, Acting Assistant Superintendent and Director of Data, Assessment & Accountability gave a presentation on Student Assessment.

Dr. Saraiya noted that some subgroups require extra assistance. Ms. Miller is pleased that the district is using the data to make data-driven decisions for students that need help.

NEW BUSINESS FROM BOARD/PUBLIC

Mr. Patel thanked the entire school community for helping out during this time.

COMMITTEE/REPRESENTATIVE REPORTS

- Student Representative Report – None
- MTEA Report – Mr. Scott Mason, MTEA President, reiterated what Mr. Patel stated. The annual MTEA Music from the Heart production is cancelled. The MTEA will continue to give its four \$1,500 scholarship donations to students.
- Board Member Delegate/Representative Reports – (SCSBA, PTSAs, MAC, Legislative, NJSBA, Ed. Services Commission, etc.) - Mr. Patel reported that the PTA will soon finish its Six Flags Program; the PTO will be accepting nominations for staff participation awards; LMS yearbook sales will be ending soon. Ms. Tonkin stated that the Education Service Commission will be providing support services during this time. The Municipal Alliance didn't have an update.

Board Committee Reports

- Assessment, Curriculum and Instruction Committee (ACI) – Ms. Miller reported that the committee received an overview from Ms. Fiona Borland, Director of Curriculum, Instruction and Staff Development, on the distance learning process; teachers collaborated on lesson plans at all grade levels, staff continues to look for ways to improve innovation content and additional learning platforms for students with special needs; there was also a discussion about mental health; State Assessment presentation was given as well. Dr. Saraiya asked if students will be ready to come back in September. Ms. Miller stated they are doing everything possible to be ready. Ms. Rao inquired about the infrastructure that may be needed if distance learning continues into the fall. Ms. Miller stated Ms. Borland will be reviewing the resources that may be needed and will address the committee again. Ms. Bursh asked about extending the school day past noon. Ms. McLoughlin stated it's basically the same amount of instructional time if you take lunch and electives into account.
- Operations, Facilities and Finance Committee (OFF) – Mr. Tiwari reported that the committee focused on two areas. The first area the committee focused on was the cost impact of COVID-19 on our operations, transportation and facilities. Our food services company is providing meals to the students that are eligible for free or reduced priced meals. The committee also discussed the legislation issues and how it may impact the budget. The second area that the committee focused on was regarding the adoption of the budget along with the presentation.
- Policy and Communications Committee (PCC) – Ms. Bursh reported that the committee met last Thursday. There are five policies and regulations on the agenda for second reading. There will be more policies at next month's meeting. She also stated that if the community thinks some of the policies are hurting them, community members should reach out to the PCC committee.
- Human Resource Committee (HRC) – Mr. Patel reported that the committee met on April 21st. Discussion included finalization of the superintendent's contract and the teacher mentoring plan. Ms. Mattis discussed personnel items 4.1, 4.2 and 4.3 which are on tonight's agenda.

- President's Report – Ms. Tonkin reported that it was with great pleasure the board of education unanimously recommended the appointment of Ms. Mary McLoughlin as the permanent Superintendent of Schools. Ms. Tonkin also held a moment of silence for all those who have been affected by the loss of loved ones due to COVID -19.

- 1.4 Resolution Opposing Delay in Transmission of Property Tax Revenue to School Districts – approve the following resolution:

WHEREAS, Assembly Bill 3902, currently pending in the State Legislature, would authorize the Department of Community Affairs to permit municipalities to delay the transmission of property tax revenues to school districts during gubernatorial-declared emergencies; and

WHEREAS, New Jersey's public schools are highly dependent on property tax revenue to support education programs; and

WHEREAS, on average, local property taxes constitute close to 60% of public school revenue, with the percentage even greater in other districts such as Montgomery where it constitutes 86%; and

WHEREAS, a delay in payments from municipalities would result in a financial crisis for school districts, seriously disrupting the educational process—and bringing it to a halt; and

WHEREAS, although public school buildings are closed during the current health emergency, the education of our students is taking place through remote learning and home instruction; and

WHEREAS, continued timely transmission of school property taxes is critical for the education process to continue without interruption; and

WHEREAS, even though municipalities are designated as the authorities to collect property taxes, these taxes are levied for specific purposes—e.g., municipal, school, county, fire district—and these obligations must continue to be met; and

WHEREAS, as currently written, A-3902, which is intended to ease a financial burden on municipalities, would place a severe strain on school districts and the students and families that they serve; and

WHEREAS, the Montgomery Township Board of Education recognizes the impact of the current public health emergency on the state and local governments, as well as local school districts, but believes this legislation would worsen the situation for our communities.

NOW, THEREFORE, BE IT RESOLVED that the Montgomery Township Board of Education urges the State Senate and the Governor to oppose A-3902; and be it further

RESOLVED, that this resolution be delivered to Governor Phil Murphy, State Senate President Stephen M. Sweeney, Assembly Speaker Craig Coughlin; and the 16th Legislative District's representatives in the state Senate and General Assembly; and be it further

RESOLVED, that copies of this resolution be sent to the New Jersey School Boards Association.

WHEREAS, the Board Secretary's and Treasurer's Reports for the month ending March 31, 2020 are presented for the Board to accept and are on file in the Office of the School Business Administrator;

NOW THEREFORE BE IT RESOLVED, the Board of Education of the Montgomery Township School District acknowledges receipt of and accepts the Board Secretary's and Treasurer's Reports for the month ending March 31, 2020; and

BE IT FURTHER RESOLVED, that the Board Secretary and the Board of Education certifies that no budgetary line item account has been over-expended and that there are sufficient funds available to meet the District's financial obligation.

3.6 Food Service Management Agreement – that the Board of Education renew the agreement with COMPASS GROUP USA, INC., by and through its CHARTWELLS Division as the district's Food Services management company for the 2020-2021 school year with the following management fee, guaranteed return and investment:

A. DURATION OF AGREEMENT

- 1) This agreement begins on July 1, 2020 and ends on June 30, 2021.

B. MANAGEMENT FEE(S)/GUARANTEES

1) FEES

Management Fee. Chartwells shall charge the Local Education Agency a Management Fee of Eleven Thousand Three Hundred Ninety-Four dollars (\$11,394) per month for the ten (10) months for an annual total of One Hundred Thirteen Thousand Nine Hundred Forty dollars (\$113,940) during the academic year.

2) GUARANTEE

Guaranteed Return. Chartwells guarantees that the return to the LEA from the Food Service Program for the school year will be at least \$75,000 and is unlimited. Guarantee Reimbursement conditions and assumptions remain the same as previously agreed upon in the First Renewal Fee contract.

BE IT RESOLVED by the Montgomery Board of Education (hereinafter referred to as the "Board") that the terms, stipulations and conditions as established in the Settlement Agreement and Release between the Board and the Parents of a student whose name is on file in the Superintendent's office, and which Agreement is located in the student's file, are

hereby adopted and approved by the Board. The Board President and Business Administrator/Board Secretary are hereby authorized and directed to execute the Settlement Agreement and Release and any other documents necessary to effectuate the Settlement Agreement.

- 3.9 Appointment of Professional Service - approve the appointment of Phoenix Advisors as Financial Advisor for Continuing Disclosure Agent services for \$1,000 base fee and \$200 initial setup fee for each new bond issue set up during the year for the 2020-2021 school year.
- 3.10 Approve the Following Resolution Regarding the Refunding of all or a Portion of the Outstanding Callable School Bonds –

REFUNDING BOND ORDINANCE OF THE BOARD OF EDUCATION OF THE TOWNSHIP OF MONTGOMERY IN THE COUNTY OF SOMERSET, NEW JERSEY, PROVIDING FOR THE REFUNDING OF ALL OR A PORTION OF THE OUTSTANDING CALLABLE SCHOOL BONDS OF THE SCHOOL DISTRICT, DATED FEBRUARY 25, 2010, ISSUED IN THE ORIGINAL PRINCIPAL AMOUNT OF \$14,125,000, AND/OR ALL OR A PORTION OF THE OUTSTANDING CALLABLE REFUNDING SCHOOL BONDS OF THE SCHOOL DISTRICT, DATED MAY 10, 2011, ISSUED IN THE ORIGINAL PRINCIPAL AMOUNT OF \$17,215,000, APPROPRIATING NOT TO EXCEED \$11,000,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF NOT TO EXCEED \$11,000,000 REFUNDING BONDS TO PROVIDE FOR SUCH REFUNDING

BE IT ORDAINED BY THE BOARD OF EDUCATION OF THE TOWNSHIP OF MONTGOMERY IN THE COUNTY OF SOMERSET, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. The Board of Education of the Township of Montgomery in the County of Somerset, New Jersey (the "School District") is hereby authorized to refund all or a portion of the outstanding callable School Bonds of the School District originally issued in the principal amount of \$14,125,000 and dated February 25, 2010 (the "2010 Bonds") and/or to refund all or a portion of the outstanding callable Refunding School Bonds of the School District issued in the original principal amount of \$17,215,000 and dated May 10, 2011 (the "2011 Bonds") (the 2010 Bonds and the 2011 Bonds are collectively referred to herein as the "Prior Bonds"). The 2010 Bonds maturing on or after September 1, 2021 (the "2010 Refunded Bonds") may be redeemed at the option of the School District in whole or in part on any date on or after September 1, 2020 (the "2010 Redemption Date") at a redemption price equal to 100% of the 2010 Refunded Bonds to be redeemed plus accrued interest, if any, to the 2010 Redemption Date.

The 2011 Bonds maturing on or after August 1, 2021 (the "2011 Refunded Bonds") may be redeemed at the option of the School District in whole or in part on any date on or after August 1, 2020 (the "2011 Redemption Date") at a redemption price equal to the par amount

of the 2011 Refunded Bonds to be redeemed plus accrued interest, if any, to the 2011 Redemption Date.

Section 2. In order to finance the cost of the purpose described in Section 1 hereof, negotiable refunding bonds (the "Refunding Bonds") are hereby authorized to be issued in the aggregate principal amount not to exceed \$11,000,000 pursuant to N.J.S.A. 18A:24-61 et seq.

Section 3. An aggregate amount not exceeding \$150,000 for items of expense listed in and permitted under N.J.S.A. 18A:24-61.4 has been included in the aggregate principal amount of Refunding Bonds authorized herein.

Section 4. The purpose of the refunding is to incur an interest cost savings for the School District.

Section 5. A supplemental debt statement has been prepared and filed in the offices of the Montgomery Township Clerk and the Rocky Hill Borough Clerk (collectively, the "Constituent Municipalities") and the Business Administrator/Board Secretary and in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey as required by law. Such statement shows that the gross debt of the Constituent Municipalities as defined in the Local Bond Law and the school debt of the School District is increased by the amount the Refunding Bond authorization exceeds the amount of the proposed refunded bonds.

Section 6. No Local Finance Board approval is required as the issuance of the Refunding Bonds will comply with the requirements of N.J.A.C. 5:30-2.5.

Section 7. The Board President, the Superintendent, the Business Administrator/Board Secretary and other appropriate representatives of the School District are hereby authorized to prepare such documents, to publish such notices and to take such other actions as are necessary or desirable to enable the School District to prepare for the sale and the issuance of the Refunding Bonds authorized herein and to provide for the redemption of Prior Bonds referred to in Section 1 hereof.

Section 8. This bond ordinance shall take effect immediately after final adoption.



4.2 ESY Coordinator

WHEREAS, the Montgomery Township Board of Education and the Montgomery Township Education Association are parties to a collective negotiations agreement for the 2018-2019 through 2021-2022 school years (“the Agreement”); and

WHEREAS, the parties entered into a Sidebar Agreement for the 2019-2020 school year only to provide for a stipended position of an ESY Coordinator; and

WHEREAS, the parties are desirous of continuing the arrangement for the remainder of the Agreement; and

NOW, THEREFORE, based upon the foregoing premises and mutual promises and covenants contained herein, the parties hereby agree to extend the Sidebar Agreement currently in effect through the 2021-2022 school year only. All of the remaining terms and conditions in either the Agreement or the Sidebar Agreement not specifically addressed herein shall remain in full force and effect.

4.3 Superintendent Appointment

BE IT RESOLVED that the Montgomery Township Board of Education (hereinafter referred to as the “Board”) appoints Mary McLoughlin (hereinafter referred to as “McLoughlin”), as the Superintendent of Schools for the Montgomery Township School District effective July 1, 2020 and ending on June 30, 2023.

BE IT FURTHER RESOLVED that this Employment Agreement has been submitted to and approved by the Interim Executive County Superintendent, according to standards adopted by the Commissioner of Education, pursuant to N.J.S.A. 18A:7-8(j).

BE IT FURTHER RESOLVED that the Board approves the Employment Agreement with McLoughlin for the position of Superintendent of Schools for the foregoing period of appointment, which Employment Agreement is attached to this Resolution and made a part hereof.

BE IT FURTHER RESOLVED that the Board hereby authorizes the Board President and the Interim Business Administrator/Board Secretary to execute, on behalf of the Board, the Employment Agreement by and between the Board and McLoughlin.
