Representative Reports

Student Representative Report

Ms. Helen Zhang, student representative, report that today was the first day of school, and it was fantastic to see familiar faces and meet new people. The faculty welcomed everyone with warm greetings and made it feel like the students had never left in the first place! It was a great start to the school year. Some changes were made, but students were informed in an assembly. In addition, clubs and sports participation are at an all-time high. An abundant amount of Montgomery High School clubs and sports teams have already starting fundraising and planning future events. Sports teams are also making positive changes to the community this upcoming year. The Varsity fencing will be hosting lessons and educating middle school students about the sport through the Montgomery Recreation Department.

MTEA Report

Ms. Debra O' Reilly, Montgomery Township Education Association President reported that the MTEA social committee sponsored a light breakfast for all staff prior to the convocation on September 1st. The MTEA membership committee sponsored a luncheon at the new staff academy on Thursday August 20th to welcome new teachers. Thanks to a grant from the New Jersey Education Association, the MTEA is hosting tables at all back to school nights with voter registration forms, informative pamphlets relating to kids being academically successful, and free bottles of water. MTEA has reached out to the League of Women Voters who will be sponsoring a "Meet the Candidates" night for Board of Education candidates. The event will be held in the Upper Middle School media center on October 15th. Ms. O'Reilly stated that she would like to highlight accomplishments from MTEA Member, Mr. Paul Harvey, who is the head custodian at Orchard Hill Elementary School. His second children's book has been published.

Board Committee Reports

Assessment, Curriculum and Instruction Committee Report

Mr. Doshi reported that the ACI did not meet in August. The next meeting will be held September 10, 2015.

Operations, Facilities and Finance Committee Report

Mr. Goldoni reported that the committee did not meet since the last workshop meeting. The next meeting will be held September 11, 2015.

Human Resources and Negotiations Committee Report

Mr. Goldoni reported that the committee met September 3rd and discussed the following items:

- Tuition reimbursement

The next committee meeting will be held October 9th.

Policy Committee Report

Ms. Donnay reported that the policy committee met on August 21st. During the meeting they discussed the policy regarding Class Rank. The committee decided to change the word calculate to provide. The second reading will be at the September 15th meeting.

Ms. Donnay stated that the committee also discussed the property and inventory policy and changed the policy to reflect new accounting standards which have increased the capitalization threshold to \$2,000.

External Affairs/ Communications Committee Report

Mr. Hladick reported that the committee had not met since the last workshop meeting and that the next meeting date had not yet been set.

ANNOUCEMENTS BY THE PRESIDENT

Mr. Goldoni informed the board of the Candidate Forum which is to be hosted by the League of Women Voters on October 15th. He also thanked the board for their individual hard work on updating the goals for the board and the district. Mr. Goldoni then open the floor for members to speak regarding their feelings on the board and district goals.

ACTION AGENDA

PUBLIC COMMENTS

Mr. Alan Wirsul asked the Board what the cost of having the attorney at board meetings was and what the district paid for Ms. Donnay's attorney fees. Mr. Wirsul also questioned the board as to the Superintendent's bonus merits being based upon IEPs. Additionally, Mr. Wirsul asked why some school buses were late in dropping students off on the first day of school.

Mr. Goldoni responded that the attorney costs approximately \$1,100 per meeting. Mr. Goldoni further explained that the Superintendent must show evidence of success before her bonus merit is granted.

Ms. Wells noted that the district was aware of the late buses and that the transportation department had already addressed the situation. Ms. Wells also responded that Ms. Donnay's attorney fees were approximately \$38,000.

Mr. Wirsul questioned if the new bank signatures listed on the agenda meant the district was changing banks. Mr. Wirsul also questioned if tonight's agenda was different from what was posted on Friday.

Mr. Richard Specht asked if the goals would be available to the public before the board meeting. Mr. Specht also questioned who the current applicants were for the board vacancies.

Ms. Wells explained that the agenda included new signatures for the current bank accounts and did not mean that the district was changing banks. Ms. Wells stated that the three agendas were the same as those posted on Friday.

Mr. Goldoni noted that the goals would be posted along with the meeting agenda the Friday before the board meeting.
