1.2 Resolution Recognizing Somerset County Superintendent of the Year -

Whereas, the Montgomery Township Board of Education is desirous of recognizing educational excellence.

Whereas, the Somerset County Association of School Administrators has selected Superintendent Nancy Gartenberg as the 2017 Somerset County Superintendent of the Year.

Whereas, this accolade is being bestowed upon Superintendent Gartenberg in acknowledgement of her outstanding leadership and contributions in the field of education.

Whereas, in 2012, Superintendent Gartenberg was appointed superintendent of Montgomery Township School District.

Whereas, prior to joining Montgomery Township School District, Superintendent Gartenberg served as the Superintendent of South Hunterdon Regional High School District from 2007-2012, Assistant Principal and then Principal of the JP Case Middle School in the Flemington-Raritan School District, and middle school teacher in Hamilton Township.

Whereas, during Superintendent Gartenberg's tenure in Montgomery Township School District, she commissioned a special education program review that yielded two areas in need of focus for the future. One area was the need to further build district capacity with regard to our autism programming and the other area was to build district capacity in the area of reading, specifically to support students with dyslexia. This review resulted in a significant cost savings to the district while creating an incredibly strong special education department in addition the creation of a reading interventionist K-12.

Whereas, Superintendent Gartenberg has worked to pass a 18.5 million dollar bond referendum with close to 40% funding from the State.

Whereas, Superintendent Gartenberg is a staunch supporter of the arts and music programs where over 55% of Montgomery students participate in the music program, which supported the construction of a new Band Room at Village Elementary School.

Whereas, Superintendent Gartenberg advocated for full implementation of Columbia University Teacher's College Reading and Writing program in 2013 for K-8 staff so that all students are exposed to research-based and consistent reading and writing instruction.

Whereas, Superintendent Gartenberg created a partnership with Rutgers School of Labor Management for Montgomery Township School District to be one of seven school districts in New Jersey working collaboratively with the teachers association to advance student achievement.

Whereas, Superintendent Gartenberg believes in the academic as well as the social and emotional learning, goals of students and leads the District's Strategic Planning process that helped for the Portrait of a Graduate that will shape the district's next 3-5 years.

Now, therefore, be it resolved, the Montgomery Township School District hereby extends its congratulations and appreciation to Superintendent Nancy Gartenberg as the 2017 Somerset County Superintendent of the Year.

WHEREAS, the Public School Contracts Law, N.J.S.A. 18A:18A:-4.1 (b)(2) allows boards of education to use "competitive contracting" in lieu of public bidding for such Services; and

WHEREAS, the Board is seeking specific proposals from interested information technology firms that are capable of successfully providing such services.

NOW, THEREFORE, BE IT RESOLVED as follows:

- 1. The Board hereby authorizes the Business Administrator to substantially revise the specifications for the request for proposals from qualified vendors interested and capable of providing the Services desired.
- 2. The Board President and the Business Administrator are hereby authorized to execute any and all documents necessary to effectuate the terms of this Resolution.
- 3.6 <u>Settlement Agreement</u>– Approve the following resolution pertaining to a special education settlement agreement:

BE IT RESOLVED by the Montgomery Board of Education (hereinafter referred to as the "Board") that the terms, stipulations and conditions as established in the Settlement Agreement and Release between the Board and the Parents of a student whose name is on file in the Superintendent's office, and which Agreement is located in the student's file, are hereby adopted and approved by the Board. The Board President and Business Administrator/Board Secretary are hereby authorized and directed to execute the Settlement Agreement and Release and any other documents necessary to effectuate the settlement.
