# Montgomery Township School District 2023-24 Budget Development Process



## The budget development process is ever going with the board, administration and community.

- October 10, 2022 Budget Managers informed of the budget development process
- December 2, 2022 Budget requests due from all budget managers
- December 3, 2022 Administrative review of budget requests and meetings with budget managers in an ongoing process through the receipt of state aid
- March 2, 2023 Receipt of State Aid
- March 7, 2023 Recommended Budget finalized



# Montgomery Township School District 2023-24 Budget Development Process



- March 10, 2023 Discussion of Recommended Budget with the Operations, Finance and Facilities Committee (OFF) of the Board
- March 14, 2023 Presentation of Recommended Budget and Tentative Adoption of the 2023-24 Budget
- March 20, 2023 Due Date for Budget Submission to the Executive County Superintendent for Review and Approval
- April 25, 2023 Public Hearing on the 2023-24 Budget and Final Adoption



# Montgomery Township School District District Goals



#### **Goal 1: Academic**

Increase the understanding and implementation of Universal Design for Learning, a framework that guides the design of learning experiences to proactively meet the needs of all types of learners in order to improve student success across all classroom settings.

- All curriculum writing will include the principles of UDL
- Staff development will continue to develop our staff in regard to multiple ways to engage students, providing students with choices, using data to target instructions and options for students to demonstrate acquired knowledge
- New curricular resources, classroom and digital tools, are purchased to better align classroom instruction to UDL



# Montgomery Township School District District Goals



#### **Goal 2: Equity**

Increase cultural competency among administration, staff and students in order to create a work and learning environment that supports diversity, equity and inclusion.

- New classroom materials in order to increase representation of under-represented populations
- Data Analyses software to identify underachieving subgroups and to monitor growth
- Comprehensive math & ELA assessment software to track proficiency and to progress monitor student achievement



# Montgomery Township School District District Goals (Cont'd)



#### Goal 3: SEL

Increase staff training and implementation of research-based trauma-informed strategies that will decrease stress, promote wellness, build resistance and create a supportive learning environment for all students, administration and staff.

- Wellness/self-care days for students on a regular basis
- Week of respect
- Universal screenings grades 5-12 for mental health
- Staff development for trauma-informed school-based teams
- Professional development materials purchased for the continued implementation of Responsive Classroom




# Montgomery Township School District District Goals (Cont'd)



# Montgomery Township School District 2023-24 Revenue Distribution
















